Del Mar Little League (DMLL) is an all volunteer, non-profit organization dedicated to providing an opportunity for boys and girls between the ages of six and twelve to experience and play baseball in a structured and safe environment. DMLL provides an outlet for healthy activity and training in an atmosphere of wholesome community participation. DMLL is dedicated to helping youngsters become good citizens and gain confidence by, among other things, inspiring them with a goal and enriching their lives.

DMLL operates under the guidelines of the DMLL Board of Director's Constitution and By-Laws, and the Rules and Regulations of Little League Baseball Incorporated of Williamsport, Pennsylvania. DMLL is comprised of two leagues, Del Mar American Little League and Del Mar National Little League, operating under one Board of Directors.

DMLL Board of Directors

The voting members of Del Mar Little League elect the DMLL Board of Directors each year at the June General Board Meeting. Each elected board member serves a one-year term (August – July).

Candidates for the DMLL Board of Directors must submit an Application for Board Position (attached) to the current DMLL President at least one week prior to the General Board Meeting.
